**Nominations for Temporary President**

**Election of Temporary President.**

Roll call vote to elect the Temporary President

Secretary will declare the Board Member elected as Temporary President who then assumes the chair.

**VI. Seating of New Board Members**

Review of Certificates of Election.

Administration of oaths of office (or review of already executed oaths) for newly elected Board Members. Anyone authorized to administer an oath in Pennsylvania may do this, including the temporary president. New members are then seated and may take part in the remainder of the agenda.

Oath of Office authorized under Section 3.321 of the School Code:

“I do solemnly swear (or affirm) that I will support, obey and defend the constitution of the United States and the Constitution of this Commonwealth, and that I will discharge the duties of my office with fidelity.”

**VII. President for the Ensuing Year.**

**Nominations for President for Ensuing Year.**

Temporary President requests nominations for President.

Once it appears that all nominations are made, the Temporary President repeats the call for any further nominations for President and, hearing none, then requests a motion to close nominations.

**Election of President for the Ensuing Year.**

Roll call vote to elect the President would then follow by each Board Member casting their ballot publicly for the individual for whom they are voting.

Temporary President declares the Board member elected President who then assumes the chair.

**VII. Vice President.**

**Nominations for Vice President.**

President requests nominations for Vice President.

Once it appears that all nominations are made, the President repeats the call for any further nominations for Vice President and, hearing none, requests a motion to close nominations.

**Election of Vice President for the Ensuing Year.**

Roll call vote to elect the Vice President would then follow by each Board Member casting their ballot publicly for the individual for whom they are voting.

President declares the Board Member elected Vice President who then assumes the chair.
