Nomination for Temporary President

With a vote of 5 - 4, Mr. Alexander was elected as Board Vice-President for the term of December 2015 - December 2016.

Mrs. Grimm moved and Mr. Rabinowitz seconded a motion to nominate Mr. Rossi for the open seat on the Western Montgomery Career & Technology Center Joint Committee. No other nominations were made.
